NEW BUSINESS

DISCUSSION AND POSSIBLE ACTION ON MUELLER COMMUNICATIONS PROCESS OF PREPARING FOR A POSSIBLE REFERENDUM AND ASSOCIATED DRAFT OPTIONS ASSESSMENT AND DRAFT COMMUNITY SURVEY

Administrator Hilvo shared the survey, created by Mueller Communications, explaining that each household within the City and Town of Cedarburg will receive one in the coming weeks. The survey results will aid in the decision of how to fund the future needs of the Cedarburg Fire Department.

Some Council members expressed dissatisfaction with the types of questions on the survey. A discussion ensued regarding the wording of the questions and suggestions were made for changes to make ahead of mailing the surveys. The first change would be to the wording of the wheel tax statement. The second request was to change the wording to include "possible decreases" in police

services. The third request was a change to the wording defining the proposed funding alternatives as *examples* that *could possibly* be instituted.

A motion was made by Council Member Thome, seconded by Council Member Simpson, to approve the survey and documents as presented with the three changes discussed during the meeting. Motion carried with Council Member Fitzpatrick and Council Member Burkart opposed.
