NEW BUSINESS

Discussion and Possible Action on a Mural to be Located Under the Columbia Street bridge Across from Rebellion Brewery

A local artist provided samples of a mural that she is proposing to paint on the underside of the bridge. This would be visible to people sitting outside of Rebellion Brewery. It would also hide the paint that was used to cover up old graffiti and other imperfections on that part of the bridge that is highly visible to the
