Consider Request for Certificate of Appropriateness for Proposed New Building at the Northwest Corner of Washington Avenue and Mill Street at W62 N535 Washington Avenue – Cedarburg Land & Cattle LLC/Greg Zimmerschied; and Action Thereon

Architect Don Stauss reviewed the plans for Commissioners noting that the building is now slightly longer and larger than the one presented last July. He advised that the outdoor seating area will be enclosed by a low wrought iron fence.

Architect Stauss reminded the Commissioners that the Plan Commission and the Common Council were comfortable with the limited onsite parking recognizing that there is street parking available in the area. However, Planner Censky noted that many of the street stalls are being used and this development will remove those stalls from use for Mueller Funeral Home. Accordingly, he noted that parking in the area will need to be monitored.
