ANNUAL REVIEW AND CERTIFICATION OF CODE OF ETHICS

The Landmarks Commission reviewed and certified the Code of Ethics.

REGULAR BUSINESS

Petitioner is Requesting Approval to Change the Window, Trim, and Door Paint Color for Property Located on W63N670-672 Washington Avenue, and Action Thereon.

Action: Motion made by Commissioner Smith, seconded by Commissioner Krimmel to approve the change to the window, trim, and door color for the property located at W63N670-672

Washington Avenue. Motion carried without a negative vote with Commissioner Forbes excused.

Applicant is Requesting Approval for a Rooftop Screening Fence Separating HVAC from Dining Area at Brunch Cedarburg, located at W62 N535 Washington Avenue, and Action Thereon.

Ron Issleb from the Khalek Building Services, who are contracted to install the rooftop screening fence, was in attendance and explained that the general fence would be painted solid gray with no white trim. He also explained that it would only be two inches taller than the stair tower.

Action: Motion made by Commissioner Pape, seconded by Commissioner Smith, to approve the rooftop screening fence separating the HVAC from the dining area at Brunch Cedarburg, located at N62W535 Washington Avenue. Motion carried without a negative vote with Commissioner Forbes excused.

Applicant is Requesting Approval for Masonry Repairs to the North and South Walls of the Coffee Roastery Building, Located on W62 N603 Washington Avenue, and Action Thereon.

Commissioner Kubala asked the petitioner how they would remove the current masonry and noted that they were submitting the repairs to US Heritage, which is highly respected in terms of restoration. The applicant, Peter Nichols of Statz Restoration and Engineering, was present and explained that they would be using center cut and chisel to carefully remove and replace the bricks, along with carefully color matching the bricks and color matching the original color of the mortar.

Action: Motion made by Commissioner Krimmel, seconded by Commissioner Yip, to approve masonry repairs to the north and south walls of the Coffee Roastery building, located at W62 N603 Washington Avenue. Motion carried without a negative vote with Commissioner Forbes excused.
