The Police Department has some new technology, syncing of squad car emergency lights when the squads are in relatively close proximity to each other. This reduces distraction and confusion to officers and other motorists. Also, when a driver's or passenger's door of the squad is opened, the lights shut off on that side of the vehicle to reduce distraction to the officer.

Update of Fire Department Projects

Fire Chief Vahsholtz reported that the Fire Department will have their annual Awards and Recognition picnic on September 11, 2021 at Cedar Creek Park.

The Fire Department experienced no problems related to the Ozaukee County Fair at Firemen's Park. There were record-breaking crowds.
