UNFINISHED BUSINESS

Discuss Possible Yarn Decorating Event in Downtown Cedarburg; and Action Thereon

Melissa Wraalstad has been working with Sue Schrader to do this event for a Summer Sounds night. They would have a group of volunteers decorate the bandshell and trees in the park with yarn. The goal is to highlight fiber arts in Cedarburg. Moving the event out of the downtown area to the park would be much easier to accomplish. A discussion ensued regarding the event.
