ELETION OF VICE CHAIRPERSON: AND ACTION THEREON

Motion made by Commissioner Guse, seconded by Commissioner Dries, to reelect Commissioner Oakes as the Vice Chairperson. The motion carried unanimously with Mayor O'Keefe excused.

CONSIDER REQUEST FROM N32 W7367 LINCOLN BOULEVARD FOR COST PARTICIPATION IN REPLACING A CONCRETE DRIVE APPROACH WHICH IS HEAVED BY A CITY STREET TREE; AND ACTION THEREON

Director Wiza stated that resident Dennis Smith of N32 W7367 Lincoln Boulevard has a concrete drive approach which appears to be heaved several inches by roots from a City street tree which is located about two feet off the edge of the driveway. Staff would concede that the raised concrete is caused by the roots.

Mr. Smith is requesting that the City replace 1/3 of the approach and about 7.5 feet of heaved curb and gutter. He stated that someone has already tripped on the raised concrete.

Discussion was held and Assistant City Engineer Mike Weiser will meet with City Forester Kevin Westphal to hold discussions on removing the tree.

Motion made by Commissioner Guse, seconded by Commissioner Beck, to replace 1/3 of the drive approach as requested due to safety issues. The motion carried unanimously with Mayor O'Keefe excused.

REVIEW PROPOSED 2021 ENGINEERING AND PUBLIC WORKS, CEMETERY AND WATER RECYCLING CENTER OPERATING AND CAPITAL BUDGETS; AND ACTION THEREON

Assistant Engineer Weiser updated the Commissioners about Washington Avenue milling and overlay. This will be from Jackson Street to Lincoln Boulevard about 900' of the south bound lane, and full width on the south end. Washington Avenue would be closed for 2 days per contract.
